Among the many inputs influencing the supervisory role are those of culture and parallel process. Parallel process defines the simultaneous interactions between training program, agency, supervisor, student, and client which converge during the supervisory hour. The cultural identities of each of these contributors interface continuously in dynamic ways which can be at once enriching and challenging. Cultural parallel process factors affect the professional development of the art therapist and client service.	9:00-10:0am	Presentation of an overview of Cultural Aspects of Parallel Process in Art Therapy Supervision
Cultural issues within the institution and therapeutic relationships are intensified by many layers of feeling states, actions and thoughts, which are finally brought to the supervisor to sort out and re-process. Added to this is the cultural similarity or contrast between the student and supervisor, which similarly affects both the relationship itself and the quality of communication about supervisory issues.	10:00-11:0am	Presentation of Parallel Process and Cultural Issues and how it affects the professional development of the art therapist and client service
In this pre-conference course, supervisors will revisit the concept of parallel process in supervision with emphasis on cultural issues in order to gain a more thorough understanding of this process. Participants will explore their own cultural identities in relationship to their work as art therapists, their professional identities within their institutions and particularly to their relationships with students. This course will utilize both lecture and discussion of theoretical points as well as art making and role playing to deepen the absorption of this material. Participants are encouraged to bring supervisory vignettes regarding cultural issues and artwork for discussion. Please note that cultural issues can focus primarily on the supervisor-student relationship, the student-client relationship, or institution-client/student/supervisor relationship.	11:00-11:15am	Break

Who Should Attend?

This course is especially appropriate for art therapy Practica supervisors, art therapists providing ATR registration supervision and other professionals supervising art therapists at their site.

Program Objectives:

The goal of this pre-conference course is to provide advanced supervision training in parallel process with specific emphasis on cultural aspects of the interface between supervisor and student identities as well as how those interact with the cultural identities of clients and institution. This training is being provided for fieldwork supervisors of graduate art therapy students as well as those who supervise art therapists for ATR.

Participant Learning Objectives:

- The art therapy supervisor will describe at least one example of cultural parallel process at her/his own site through art or discussion.
- The art therapy supervisor will express, verbally or visually, at least one cultural related quality of the patient population that can influence the student's learning process.
- The art therapy supervisor will express, verbally or visually, at least one cultural factor that can influence the supervisory relationship.

Format:

Modalities to be employed in the Program will be a combination of didactic, interactive, and group activities to address a defined scope of the realities of Cultural Aspects of Parallel Process in Art Therapy Supervision. Teaching method will include lecture.
