

Corrected October 2021 – 3rd Quarterly Budget and Expenditure Reporting under CARES Act Sections 18004(a)(1) Institutional Portion and Student Aid Portion and 18004(a)(2) Minority Serving Institutions (MSI) Portion.

Caldwell University signed the Funding Certification and Agreement Emergency Financial Aid Grants to Students under the Coronavirus Aid, Relief, and Economic Security (CARES) Act Section 18004(a)(1) of the CARES Act on April 14th, 2020, Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA), Public Law 116-260, signed into law on December 27, 2020 and the American Rescue Plan (ARP), Public Law 117-2, signed into law on March 11, 2021.

As of September 30, 2021, Caldwell University has been awarded \$11,561,052 in total HEERF funding since March 2020: \$4,854,137 for student aid, \$6,005,796 for institutional aid and \$701,119 for the MSI portion.

Regarding the disbursement of emergency grants to students in 3rd quarter, \$2,739,270.46 of the more recent HEERF III funds was awarded to 2,074 eligible students. All eligible students enrolled in Fall 2021 were given an award of either \$2,200 [students with expected family contribution (EFC) between \$0-999 = 660 recipients]; \$1,500 (EFC of \$1,000-4,999 = 255 recipients); \$1,200 (EFC of \$5,000-\$14,999 = 295 recipients); or \$600 (EFC of \$15,000+/non-filers = 864 recipients). No application was used for this disbursement round; distribution amounts were determined by the EFC range based on students' Free Application for Federal Student Aid (FAFSA®) filings.

Remaining funds will be disbursed on a need basis due to student's extenuating circumstances as identified by the university going forward. To date, \$4,693,524.46 has been awarded to 2,950 students since March 2020.

Caldwell University was allocated an additional \$2,821,588 in HERRF III institutional funds in May 2021; in August 2021, \$1,022,158 was used to replace lost revenues. The university was also allocated a new HERRF III institutional award of \$349,619 for Minority Serving Institutions in August 2021; **\$203,714 was spent during the quarter to replace lost revenues.**

The revised attachment demonstrates how Caldwell University spent the HEERF Institutional Portion and MSI Institutional Grant during the period from July 1, 2021 through September 30, 2021. Please note that the university did not receive any funding under 18004(a)(3).

Posting the Form: This form must be conspicuously posted on the institution’s primary website on the same page the reports of the IHE’s activities as to the emergency financial aid grants to students made with funds from the IHE’s allocation under (a)(1) of the CARES Act, CRSSAA, and ARP (Student Aid Portion) are posted. It may be posted in an HTML webpage format or as a link to a PDF. A new separate form must be posted covering each quarterly reporting period (September 30, December 31, March 31, June 30), concluding after either (1) posting the quarterly report ending September 30, 2023 or (2) when an institution has expended and liquidated all (a)(1) Institutional Portion, (a)(2), and (a)(3) funds and checks the “final report” box. IHEs must post this quarterly report form no later than 10 days after the end of each calendar quarter (October 10, January 10, April 10, July 10). Each quarterly report must be separately maintained on an IHE’s website or in a PDF document linked directly from the IHE’s HEERF reporting webpage.
